# **IV. Informational Items**

SPWRP staff discussed these informational items with the Committee:

- Biosolids Land Application Research Program
  - Blair Corning, SPWRP Deputy Director Environmental Programs, discussed the facilities' intention to renew the annual biosolids land application research project with Colorado State University (CSU) Department of Soil and Crop Sciences. Since 1982, this research has provided long-term data and enhanced understanding of biosolids generated at SPWRP. A proposal outlining a yearly cost of \$97,312 for 2020, was received and reviewed by staff. These funds are allocated in the 2020 SPWRP budget and are a 23% reduction from 2019 costs, due to SPWRP staff initiated renegotiation of indirect cost rates.
- SPWRP Uniforms
  - Brenda Varner, SPWRP Government Communications Specialist, informed the Committee on modifications to the 2020 SPWRP uniform program. After a year of research and evaluation, staff elected to move away from using a uniform service provider and purchase staff uniforms directly. This initiative includes a uniform cleaning service provided by a local laundry service company.
- Director Updates:
  - Director Van Ry thanked the Committee for their continued support of SPWRP's achievement of completing the Gas Recovery Facility and the associated Ribbon Cutting Ceremony on Thursday, October 31, 2019.
- Three (3)-Month Outlook for Supervisory Committee Action Items
- SPWRP Influent Flow and Load Summary:
  - The measured flow to SPWRP averaged 18.1 mgd in October 2019, which is a decrease of approximately 2.7 mgd from October 2018. The measured flow split was 44.4 / 55.6 percent between the cities of Littleton and Englewood.
